**1. COMMANDER'S MESSAGE:**

I was pleased to see the large attendance at our Winter Council of Administration meeting in Portsmouth. It was also a pleasure to see the large presence at our banquet where we honored the top winners of our Patriots Pen, Voice of Democracy and Teacher of the Year contests. First place Voice of Democracy winner Sophie I. L. Crowder from our 4<sup>th</sup> District presented her essay to a hushed crowd and it was clear why she was the winner. I am confident that she will place highly at the National awards ceremony in Washington DC in March. Sophie was presented a check for \$10,000 by me and Bob Jekanowski from Powerhouse Gaming. Sophie left with over \$11,000 thanks to additional awards added to the total.

Past Commander-in-Chief Glen Gardner was our National representative and gave an inspirational speech to the audience. I commented that the media will cause many to believe that our country is going downhill. However, the presence of these students and teachers proves that patriotism is alive and well and that these folks will be the future leaders of our country. I also stated that this wasn't only happening in Virginia, but it was occurring in all the VFW Departments.

On January 15 we sent a delegation to Richmond to lobby for changes in the charitable gaming statutes that will level the playing field with non-charitable gaming. Currently, due to antiquated rules, we are hampered in our efforts to raise charitable funds through gaming while those who run for-profit gaming face no regulation whatsoever. There are also numerous gaming machines throughout the commonwealth which were placed based on loopholes in the gaming laws, but to the true spirit of the law, need to be addressed. We were able to meet with the Chair of the committee addressing these issues as well as many other powerful legislators. We feel that they were sympathetic to our concerns and we have hope for a satisfactory outcome. We plan to visit again on January 29 to continue our efforts.

On January 16, 1<sup>st</sup> District Commander Jim Gierlak, Membership Chair Kathy Goodall and I joined a group of veterans for breakfast at Lee's Restaurant in Kilmarnock. We discussed forming a new Post in the Northern Neck and received several applications. We are currently about 2/3 of the way to having the required number of applicants to get it done. Future events are being planned.

Our successes at recruiting at gun shows continues. With the current activity on gun legislation in Virginia attendance at these shows has been phenomenal. This gives us a huge audience to approach about our programs and benefits of membership. I thank all of you who have taken time out of your weekends to support our efforts.

Again, I'd like to stress the mantra "Membership, Membership, Membership". It is only through a strong membership that we can continue to have influence with our legislators and continue the programs that benefit our veterans, their families and our youth. Imagine how strong we'd be if each member recruited one new member.

### **5. ACTIVE MEMBERSHIP:**

The National By-Laws provide for only one type of membership; active membership. There are no provisions in the National By-Laws, nor is there any authority or justification for issuance of Club Membership cards. Associate Member cards, Honorary Membership cards, Courtesy Membership cards or any other special type of cards. Any Post issuing such unauthorized cards, or conducting club operations open to the general public, endangers its standing with the Internal Revenue Service as a non-profit organization. Officers signing outlaw cards admitting non-members to VFW premises are subject to disciplinary action. National and Department officers cannot defend practices that conflict with VFW By-Laws or procedures.

### **6. BY-LAWS AND MANUAL OF PROCEDURE:**

All Officers should obtain current 2020 copies of the podium edition of the Congressional Charter, By-Laws, Manual of Procedure and Ritual. Copies of the revised edition of the Congressional Charter, By-Laws, Manual of Procedure and Ritual are available through the VFW Store at National Headquarters. The 2020 revised edition reflects the amendments adopted by the 120<sup>th</sup> National Convention, which became effective on August 23, 2019.

### **7. BY-LAWS COMMITTEE:**

The National and Department By-laws are the governing document of the organization. Along with the National Manual of Procedure and National Ritual, there is nothing not covered but none of these are permanent documents. Should your Post or District feel there is a need for change, propose and pass the change you wish to see. Please send those adopted recommendations, with a cover letter signed by the Post or District Commander stating when the motion was adopted, to the State Headquarters **NO LATER THAN MAY 1<sup>ST</sup>**. Those properly recommended will be considered at the State Convention in June.

LOWE be removed from the rolls of Grover King Post No. 1115, Hillsville, Virginia, for a period of six (6) months commencing October 6, 2019 and ending on April 6, 2020. On completion of the suspension period, his membership will be transferred to Department of Virginia Member-at-Large after which time he will be eligible to transfer to a Post of his choosing in accordance with Section 107.

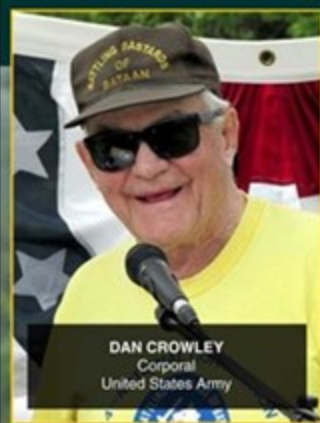
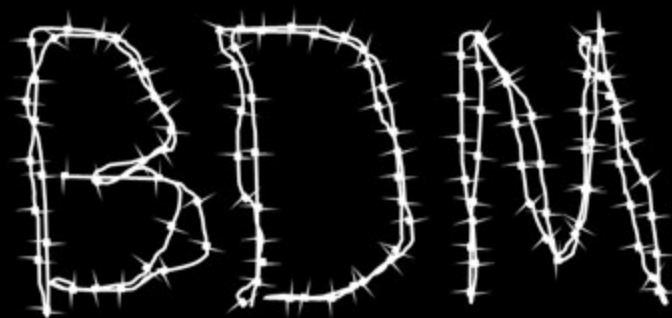

#### **WELCOME TO RENO**

Reno Tahoe is a premier four-season destination with countless activity options for visitors including award-winning craft breweries, bars and restaurants, diverse outdoor excursions, exciting art and cultural activities, and historical attractions. Recent investments in the Midtown District, Brewery District and downtown Reno all make the destination even more amazing! This is a great time to enjoy the Reno Tahoe experience!

#### **CONVENTION LOCATION**

Convention activities will take place at the Reno Sparks Convention Center located at 4590 South Virginia Street, Reno, NV

#### **LOCATION**

**Reno-Sparks:** Located at the base of the eastern slope of the Sierra Nevada, 13 miles east of the Nevada-California state line on Interstate 80. **Lake Tahoe:** Bisected by Nevada-California borders, Lake Tahoe is 40 minutes southwest of Reno in the Sierra Nevada.

Nine major airlines service the Reno-Sparks area making it accessible from most U. S. cities. Reno-Tahoe International Airport welcomes 120 daily [flights](#) with more than 50 airports nationwide offering either non-stop or one-stop air service.

Reno-Sparks averages more than 300 days of sun each year with wide variations in temperatures during a 24-hour period. Its dry, mild climate makes it attractive to visitors year-round. Rand McNally rates the area #1 for outdoor activities.

Average temperature in Reno during July: High – 90, Low-58, Lake Tahoe: High 80s, Low-40s

#### **WHAT TO WEAR**

A general guideline for attire for the convention is business casual for meetings. For VFW members, it is always appropriate to have your cap on hand for meetings. Jackets are not required unless you are an award recipient (for example, Community Service Post, All American Commanders) and may be on stage to receive your award as photographs are taken during those functions. You may wish to bring and wear patriotic or themed apparel for the Tuesday night Patriotic Celebration. (*See Patriotic Celebration information in this document*).

#### **AIRPORT SHUTTLE**

The airport is 10 minutes from downtown. Most hotels, offer complimentary airport to hotel shuttle service. Taxis, limousines, buses and shuttles provide airport service to anywhere in the valley.

#### **PUBLIC TRANSPORTATION**

Taxis, buses and rental cars are available. Visit [www.visitrenotahoe.com](http://www.visitrenotahoe.com) for additional information. RTC RAPID is a limited-stop bus service designed to move swiftly along its route, similar to a light rail system. RTC RAPID makes only six stops as it traverses Virginia Street between downtown Reno and the Meadowood Mall. An electronic system permits drivers to control traffic signals as they approach intersections, eliminating long waits at red lights. RTC RAPID is equipped with new articulated 60-foot hybrid diesel/electric buses.



RTC RAPID runs every 10 minutes from 7 a.m. to 7 p.m., Monday through Friday. It's every 30 minutes from 6 a.m. to 7 a.m. and 7 p.m. to 9 p.m. On Saturdays, Sundays, and holidays, RTC RAPID service is every 12 minutes from 6:36 a.m. to 7 p.m. and every 30 minutes from 7 p.m. to 8 p.m.

## **PARKING**

Parking at most hotels is complimentary. Parking information, costs etc., for the convention center will be available at a later date.
