3. ACTIVE MEMBERSHIP:

The National Bylaws provide for only one type of membership: active membership. There are no provisions in the National Bylaws, nor is there any authority or justification for issuance of Club Membership cards, Associate Member cards, Honorary Membership cards, Courtesy Membership cards or any other special type of cards. Any Post issuing such unauthorized cards, or conducting club operations open to the general public, endangers its standing with the Internal Revenue Service as a non-profit organization. Officers signing outlaw cards admitting non-members to VFW premises are subject to disciplinary action. National and Department officers cannot defend practices that conflict with VFW Bylaws or procedures.

4. ALL AMERICAN DASHBOARD:

Military Assistance Program grants have been launched to show Departments and Posts how much in grant assistance that has been received from National HQs to supplement the Unmet Needs financial grants & VFW Sport Clips Help-A-Hero scholarship statistics. The information charts reside on the KPI tools section.

Please encourage Posts to read the 2021-2022 Membership program. Many Posts don't understand they need to sign up 5 New Action Corps subscribers, create a Facebook page, 2 separate partnering events along with a 10% increase in Community Service Impact from last year. They must submit reports through the dashboard to gain credit.

5. AMAZONSMILE:

Amazon donates 0.5% of the price of eligible AmazonSmile purchases to charitable organizations selected by our customers. Our very own Foundation is listed – The Virginia Veterans Foundation.

6. AUDITS:

Attention of Post Commanders is directed to Section 218(a)(11) of the National Manual of Procedure, Officers: Duties and Obligations. Trustees' Report of Audit must be prepared in detail within thirty (30) days from the end of each quarter, one of which ended March 31 and is **NOW PAST DUE**.

7. AWARDS:

Awards and All-State judging information were in March's General Orders, along with the various entry forms.

8. CHAPLAIN VACANCY:

Effective April 25, 2022, there is a vacancy in the position of State Chaplain. In accordance with section 520 of the National Bylaws and Manual of Procedure, nominees to fill the vacancy through the remaining term of office are now being accepted.

Nominees for the vacancy will be accepted through May 10, 2022. A special meeting of the council will be held on Wednesday May the 11th at 6:30pm.

9. COMMUNITY SERVICE REPORTING CUTOFF:

Comrades,

The Community Reporting process for Posts in Virginia has not changed from previous years. The reports entered from 1 May 2021 thru 30 Apr 2022 are the ones that count for the current program year.

As you know, Community Reports entered in the Online Reporting portal on the Virginia VFW website are automatically reported to National on a nightly basis. This is what gets used to meet the new All American requirement of a 10% increase from last year.

The numbers included for this year include any reports entered from 1 May 2021 thru 30 Apr 2022. This means that you only have until the end of April to enter your reports to meet the 10% increase for this year.

Reports entered after 30 Apr 2022 WILL NOT BE INCLUDED in this year's numbers and WILL NOT COUNT towards the 10% increase over last year, even if the activity entered occurred during that period.

To be cleared, a report entered on 1 May 2022 about an event that took place on 30 Apr 2022 WILL NOT COUNT in the numbers for this year.

Please ensure that you get your reports for the year entered before the deadline of 30 Apr 2022.

10. DELEGATE FEES:

In accordance with the National By-Laws Section 222 (C), each Post will pay in accordance with Department By-Laws a delegate registration fee for each delegate to which the Post shall be entitled.

Therefore, you must submit your delegates list to the Department in accordance with Section 222 of the Manual of Procedure (B) along with a check in the amount of \$3.00 for every delegate your Post is entitled to as of membership status of March 31. All delegate list and monies should be sent to Department Headquarters by **May 27th**. Failure to do so will put your Post in arrears to the Department and Post will have no voting strength at the State Convention.

The Delegate sheet was the front page of the April General Orders.

11. DISTRICT CONVENTION MEETINGS:

Section 222 of the National Bylaws and the Manual of Procedure provides that delegates and alternates for the District Convention and meetings, Department and National Conventions shall be elected at a regular meeting in April. Posts are entitled to one (1) delegate and one (1) alternate for each thirty (30) members or fraction thereof in good standing in the Post as of March 31.

Pursuant to Section 403 of the National Bylaws and the Manual of Procedure, each District shall hold an annual District Convention for the purpose of electing District officers, such convention to be held not less than ten (10) days nor more than seventy-five (75) days prior to the convening of the Department Convention.

Pursuant to Section 417 of the National Manual of Procedure, District officers shall not assume the duties of their office until the Department Commander is installed.

District officers shall not be installed or assume the duties of their office until proof of eligibility has been submitted and properly reviewed in accordance with Section 416 of the Manual of Procedure.

12. DUTIES OF TRUSTEES:

Attention of Post Commanders is directed to section 218 of the Manual of Procedure, "Duty of Trustees." Trustees Report of Audit must be completed in detail at the close of each quarter. Commanders are reminded that accurate and complete records shall be kept by all persons handling Post funds, including the Club Manager and Bingo Chairman. These records shall be audited by Post Trustees in the same manner as Post Quartermaster and Adjutant records.

13. E-MAIL ACCOUNT ACCESS:

All email accounts were reset so the new Officers could take control of their emails as of **June 7th**. This will be the primary means of sending correspondence from State Headquarters to Post and District Officers.

You will receive all General Orders, special notices and any other documentation that you need via email. This will help cut down on postal expenses and speed up the response time for you receiving the information.

Here are directions for logging into your new account for the first time.

1. Go to Department web site www.vfwva.org.
2. Click on Resources, Microsoft 365.
3. The username is your email address; put that on the first line (see below for your new address).
4. Your default password will be **VF2021!** once you have accessed the mail program you will be asked to change it; it must contain at least one uppercase letter and one number.

For Post Officers, your address will be cdrpost176@vfwva.org where the 176 is you replace it with **your** Post number.

15. HALF-STAFF U.S. FLAG:

The U.S. Flag should be at half-staff on Memorial Day, the last Monday in May (federal holiday - half-staff until noon). Flags available at VFW Store vfwstore.org/category/flags/usflags.

IRS Form 8822-B, it is now a requirement by the IRS that all Posts submit this form. This form must be submitted anytime the Post Quartermaster changes and/or the Post address changes. This is effective January 1, 2014.

Louisa County Post 8947 was made eligible for this Free Life Membership for having 100% of their membership goal reported to State Headquarters by March 25, 2022, deadline.

19. LIFE MEMBER PAYOUT:

The following will be the 2022-2023 Life Member payout. The National Council of Administration concurred with the payout amounts at its February 28, 2022, meeting.

Additionally, on or around April 1st, the “Projected Life Member Payout” report on OMS will be updated and available for you and your Post Quartermasters to have a better idea of how many member payouts you may expect to receive. Keep in mind this is not a precise number because your payouts in September will be based on August 31st numbers, but the report provides you with a decent estimate of numbers to help you develop your budgets for the ensuing fiscal year.

As indicated in the By-Laws, payment will be made in September 2022 for all Life Members recorded as of August 31, 2022. In addition, a payment will be made in January 2023 for all Life Members processed during the period September 1 through December 31.

21. NATIONAL CONVENTION AND REGISTRATION:

The 123rd National Convention housing opened Feb. 17, 2022. Housing reservation information is located on the convention website accessed through the main VFW website at vfw.org/convention. The convention website will also have general convention information including the registration form and links to other convention related information for Kansas City, MO, July 16-21, 2022, including a tentative agenda. CONVENTION REGISTRATION – Section 222 of the Manual of Procedure states each Post will pay, in advance, a National Convention registration fee of twenty-five dollars (\$25) which shall entitle the Post to a packet of convention information and materials, and one identified registered delegate for the VFW National Convention. Each additional delegate attending the National Convention will pay a ten-dollar (\$10) delegate fee provided the Post has paid the mandated \$25 advance registration fee. All advance registrations should be mailed to the VFW National Headquarters, 406 W. 34th Street, Kansas City, MO 64111, ATTN: Convention Registration or you may register online by going to vfw.org.

24. POST ELECTIONS:

Installing officers will see that the provisions of Section 216 of the National Bylaws and the Manual of Procedure are properly carried out and that all officers are members in good standing and qualified to hold office prior to installing Post officers for the current year. Post officers shall not be installed or assume the duties of their office until proof of eligibility has been submitted and properly reviewed.

Post Election Reports must be submitted following Post election of officers in April and no later than June 1 to the National Headquarters. We highly encourage all Post Quartermasters to use the online Election Report process featured in the Online Membership System (OMS). Post Election Reports received electronically will be forwarded to the Department Headquarters.

25. POSTS IN ARREARS FOR FINANCIAL OBLIGATIONS:

Attention is directed to Section 213 of the National Bylaws concerning any Post in arrears for any financial obligations to County Council (if applicable), District, Department and National for fees, dues, poppy money, supply money, failing to have the office of Quartermaster properly bonded in accordance with Section 703, failing to ensure that the Post is properly insured in accordance with Section 709, failing to submit properly completed quarterly Post Trustees Report of Audit, Post Election Report for the ensuing year, or other obligations, shall be deprived of all representation in County Council and District meetings; County Council, District, Department and National Conventions. Such representation shall be restored promptly upon proper adjustment of such deficiencies.

26. PROOF OF ELIGIBILITY:

Post, District, Department Commanders, Adjutants and Quartermasters are reminded of the requirements of Sections 216, 416 and 516 of the Manual of Procedure with regard to proof of eligibility for all newly-elected and appointed officers. Elected and appointed officers **shall not be installed** or assume the duties of their office until proof of eligibility has been submitted and properly reviewed. Failure or refusal to submit proof of eligibility within thirty (30) days of election or appointment shall result in the office being declared vacant.

27. REPORTING:

Comrades to view whether your Post has submitted an Audit Report, Americanism, Community Service, Safety, Youth or Hospital report you should visit the Department website (www.vfwva.org).

The website is updated daily. If you have any questions, please call State Headquarters.

There will be no form for Homeless when reporting for assistance to a homeless veteran please put it on a Community Activity report under aid to others.

31. THE UNITING TO COMBAT HUNGER:

The Uniting to Combat Hunger (UTCH) Grant is now open! 32. VIETNAM WAR COMMEMORATION:

Many Posts in the Department participated in various activities surrounding Vietnam War Veterans Memorial Day on March 29th. Included are:

- Post 2524 - Culpeper – The Post’s Color Guard participated in ceremonies at the Vietnam Veteran Monument at the Culpeper County Courthouse.
- Post 4639 – Williamsburg – Hosted a “Breakfast for Veterans” with Vietnam veterans eating free.
- Post 7059 – Farmville – The Post hosted a ceremony attended by representatives of four other District 4 Posts. It included a guest speaker and refreshments. 40 certificates and lapel pins were presented to eligible veterans. Members from Posts 8446, 8902, 9855 & 9954 also attended.
- Post 7819 – Crewe – Local radio station WSVS features a half hour “Command Performance” show by Post Commander Greg Eanes. On March 29th, the show was devoted to patriotic music of the Vietnam era including Barry Sadler’s “Ballad of the Green Berets”.

- Post 9835 - Warrenton – On site at Mission BBQ in Gainesville, Post members distributed nine commemorative lapel pins and signed up two new VFW members.

In addition to the nine pins distributed on March 29th, I identified an additional five individuals who also received pins including two sent to Commander, District 4 for presentation.

This month, we will celebrate another native of Virginia who earned the Congressional Medal of Honor during the Vietnam War.

First Lieutenant Ruppert L. Sargent was born in Phoebus, near Hampton, VA on January 6, 1938. He graduated from Virginia State University and enlisted in the Army shortly thereafter. Following seven years' enlisted service, he attended Infantry Officer Candidate School at Ft Benning and was commissioned in early 1966. By March 15, 1967, he was serving as a First Lieutenant in Company B, 4th Battalion, 9th Infantry Regiment, 25th Infantry Division. On the day he earned the Medal of Honor, his unit was operating in Hâu Nghĩa Province. The citation for his Medal of Honor reads as follows:

.For conspicuous gallantry and intrepidity in action at the risk of his life above and beyond the call of duty. While leading a platoon of Company B, 1st Lt. Sargent was investigating a reported Viet Cong meeting house and weapons cache. A tunnel entrance which 1st Lt. Sargent observed was booby trapped. He tried to destroy the booby trap and blow the cover from the tunnel using hand grenades, but this attempt was not successful. He and his demolition man moved in to destroy the booby trap and cover which flushed a Viet Cong soldier from the tunnel, who was immediately killed by the nearby platoon sergeant. 1st Lt. Sargent, the platoon sergeant, and a forward observer moved toward the tunnel entrance. As they approached, another Viet Cong emerged and threw 2 hand grenades that landed in the midst of the group. 1st Lt. Sargent fired 3 shots at the enemy then turned and unhesitatingly threw himself over the 2 grenades. He was mortally wounded, and his 2 companions were lightly wounded when the grenades exploded. By his courageous and selfless act of exceptional heroism, he saved the lives of the platoon sergeant and forward observer and prevented the injury or death of several other nearby comrades. 1st Lt. Sargent's actions were in keeping with the highest traditions of the military services and reflect great credit upon himself and the U.S. Army.

His medal was presented to his widow on March 10, 1969. Lt Sargent is buried in the Hampton National Cemetery (Grave 17596). He is distinguished as the first Black Army Officer to be awarded the Medal of Honor and VFW Post 3219 in Phoebus was renamed in his honor in April 2019. The Ruppert L. Sargent Building in Hampton, Virginia houses the Hampton City Schools, Commissioner of the Revenue, Treasurer, Economic Development Department and Office of the Assessor of Real Estate. A statute of Sargent may be seen in the building's lobby.

Comrades my name is Mark Maggio and I am running for State Surgeon. I moved from New York to Virginia in 2003. I have served in a variety of positions since living in Virginia and most recently served as the State Chief of Staff for Commander Eric Mallete. In my positions with the Posts, Districts and State, I have accumulated experience in the business of the VFW and feel that I am ready to serve my fellow comrades as a state officer and eventually State Commander. My goals are to continue the work that has been done by the state over the years growing the membership and reaching out to new members, and continuing to make the VFW a strong voice for veterans.

I enlisted in the Army November of 1982 and went to Basic Training at Fort McClellan, Alabama. I served as a Smoke Generator Operator until receiving my commission from Hofstra University in May 1986 as a Chemical Officer. I served as a platoon leader and executive officer of the 363rd Chemical Company and was transferred to the 318th Movement Control Agency just prior to deploying to Saudi Arabia for Desert Shield and Storm. During Operation Desert Storm I served as Freight Movements Officer from October 1990 till July of 1991. I returned home and went on to the Transportation Officer Advanced Course then went on to serve as a Company Commander of the 623rd Transportation Company. I then served in various staff assignment in the 354th and 436th Transportation Battalions. I later served with the 1179th Transportation Brigade and the Surface Deployment and Distribution Command where I served tours in both Afghanistan and Iraq. In Iraq I was awarded the Bronze Star Medal for establishing a redeployment system that streamlined the process of units moving in and out of theater while minimizing the disruption of the change over operations and combat operations.

While serving in Post 4639 I served as Jr and Sr Vice Commander becoming Commander in 2010. I was an All State Commander in my first year. In 2018 I was elected District 3 Commander and was an All American District Commander in my first year and a All State District Commander in my second. In 2018 11 of the 15 posts in the district made All State and 7 made All American. I was asked by Commander Mallete to be his Chief of Staff and worked in that position during the 2020-21 term. I am a member of the State Honor Guard and I am currently the Treasurer of the Commanders Club. I am also a member of the Military Order of the Cooties, where I currently serve as the Sky Pilot.

I am currently employed by the United States Army working at Fort Eustis for the Future Concepts Center under the Army Futures Command. I have been a civilian employee of the Department of the Army since 2010. My girlfriend Rosanne is a member of the Auxilliary and her father was a victim of Agent Orange which took his life in 2001. I have lost several comrades who served in Vietnam to Agent Orange and cancer. I have lost comrades to suicide as well. It is the remembrance of those lives that drive me to a voice for veterans whose voice may be lost in the din of competing voices for Government resources and aid. I want to be the voice that breaks through and helps them get the aid that they fought for and sacrificed for. We must always remain vigilant and never assume our work is finished. No one does more for Veterans than the VFW, must not just be a slogan but our lives work. Thank you Comrades for your consideration.

State Veterans Service Officer

Must present a courteous response to all inquires, both by telephone and in person. Forward all phone inquires, recorded telephonic inquires and live inquires from veterans, their families and other officials in appropriate representative timely manner for their action.

Consistently maintain as courteous and cooperative relationship with supervisors, coworkers, and others within the organization. Contribute positively to the effective operation of the office.

Counsel and assist veterans and their dependents in the prosecution of benefits claimed with the Department of Veterans Affairs (VA). Review processed claims as to the accuracy of the disability determination under Title 38, USC and 38 CFR. Initiate and amend the veteran's claim to include any such disabilities found. Initiate appellate review when professional judgment dictates possible error by the VA disability decisions.

Respond to telephonic or written inquires from Post, County, State and National Service Officers, veterans and officials from other organizations relative to problems with the administration of the veterans benefits with the local agency of jurisdiction.

Prepare brief of cases to be certified to the Board of Veterans Appeals (BVA) in Washington, D.C. Initiate independent review and submit contentions on behalf of the veteran to the Director of Compensation and Pension Service in Washington D.C. for administrative review through the VFW National Service Office. Secure and research VA files in order to prepare response to inquires from veterans, dependents and various recognized service offices and other officials.

Appear with and represent appellants before the Board of Veterans Appeals, Traveling Boards, Decision Review Officer (DRO) and local Rating Boards. Communicate and coordinate with the VA Service Center personnel to clarify, expedite and advocate on behalf of the veteran.

Assist Post, County, State, national Service Officers, and other officials in obtaining medical information and lay evidence as needed to construct, research and prosecute a veteran's claim/appeal for benefits. Maintain daily contact with the VA Service Center and VA Medical Facilities on matters related to individual veterans or dependent requests and/or claims.

Attend required training classes, conferences and meetings. Review and record amendments and/or policy changes to Title 38, USC, 38 CFR, VA Regulations, VA manuals, VA Rating Schedules, CAVC Decisions, OGG Opinions, OVA Circulars and various VFW National and State Manuals, Bulletins and News Letters.

Be knowledgeable with the use of various computer programs (IE: MS Office, Access, Exchange, BON, VSO VACOLS, Covers, Arms, TRES, Advisor, SHARE, Map-D, Virtual VA, Lavats; ect.)

Be knowledgeable with the use of various references (IE: Federal Laws, Rules and Regulations; Merck Manual; Taber's Medical Dictionary; DSM IV; PDR; Ect.)

Assist with the development and conduction annual Post Service Officer Training.
