#### 3. BONDS:

<u>All Bonds expired August 31, 2021</u>. Please see July or August General Orders for the rate schedule for the cost of your bond and return completed forms and payment to State Headquarters. Please note the Quartermaster Bond

rate schedule **is for** the Post Officers. There is a separate schedule for your canteen employees and other who are not Post Offices but need to be bonded. Remember that persons on any and/or all accounts the Post have **Must** be bonded.

#### 4. BUDDY POPPY:

Although we emphasize Buddy Poppies on Veterans Day and Memorial Day, it is important to realize that the distribution of Buddy Poppies should be a year-round exercise. Each time a Post participates in an activity where the public will be present, Buddy Poppies should be present as a fundraising tool and simply to recognize our fallen comrades. Where the VFW appears, Buddy Poppies should be a constant reminder that we will never forget those who have perished in the name of liberty. Just as "They Gave, Will You?" is a year-round thing, so should the distribution of VFW Buddy Poppies.

Remember that your poppies should be ordered a minimum of 8 weeks in advance of your distribution date. Be sure to specify a date by which the poppies are required, do not use "ASAP."

Miscellaneous items (coin cans, buttons, posters, etc.) should be ordered directly from the VFW Store at vfwstore.org/category/programs/buddypoppy or the VFW Store/Emblem and Supply Catalog.

The Manual of Procedure provides that Post relief funds may be used for programs such as Voice of Democracy, Patriot's Pen, Citizenship Education, and Community Service as long as suggestions in the chairmen guidebooks are used as an example of promoting these programs.

Posts are further reminded that Section 711 of the Manual of Procedure provides that non-profit organizations, exempt from taxes under Section 501(a) of the Internal Revenue Code, may assist with the distribution of Buddy Poppies, provided there shall be no division of proceeds. A donation to these groups may be made from the Post general fund.

VFW SILVER, GOLD AND DIAMOND ANNIVERSARY POPPIES. The silver, gold and diamond anniversary Buddy Poppies are for Posts that are currently in their 25th, 50th or 75th anniversary years. For Posts currently in their 100th year anniversary, they can order any color and as many as they need. The anniversary poppies are approximately three times as expensive for us to produce, but because of the small quantities we deal in, we don't pass those costs on to the Posts. Please limit your order of anniversary poppies to 1,000 to ensure stock does not run out, unless you are currently in your 100th year. These are ordered through the Department and processed the same as the red poppies. Annotate on the order to National that it is for anniversary poppies and specify which one.

#### **PURCHASING BUDDY POPPIES:**

For many years, the courtesy of allowing Posts to buy Poppies and to pay later was something that was extended as a way to help Posts. However, we have started to see too many Posts still owe for Poppies at the end of the year because of not paying their bill. Effective May 30, 2019, Posts must pay before they can receive Poppies. We will continue to accept payment by check, or you can call and order over the phone with State Headquarters by using a credit or debit card. An order form can be found on the State website under Resources, then Forms.

#### 5. CITIZENSHIP EDUCATION TEACHER AWARD

The VFW Teacher of the Year award contest recognizes three exceptional teachers for their outstanding commitment to teaching Americanism and patriotism to their students. Nominations of outstanding teachers in three categories: grades K-5, 6-8 and 9-12.

<u>ATTENTION</u>: There are changes for this year's program. For starters, there is a new Teacher Entry Form. Please use the 2021-2022 Entry Form attached to the General Orders. Do not use the old tri-fold brochure entry form. Other changes include who can nominate a teacher and who is eligible. Requirements for documentation remain the same

The program dates for this year are as follows: October 31<sup>st</sup> is the Deadline for teacher nomination by the Post. Post judging should be completed by November 15<sup>th</sup> and winners sent to District. District judging should be completed by December 15<sup>th</sup> and winners forwarded to the Department by December 20<sup>th</sup>. Department judging will be completed by December 23. District chairpersons will provide District Reports with their District winners to the State Chairman. State winners will be recognized at the Winter Council of Administration in Portsmouth in January 2022.

#### 7. DIGITAL MEMBERSHIP CARDS:

Members now have the ability to download their digital version of their membership card. Depending on whether a member has an iPhone or Android, they will be able to download and access their digital membership card from the VFW app.

This will not replace the physical VFW membership card - we will still be sending out membership cards to all our annual and Life members. This is intended as another option for our members' convenience. When asked to show a VFW membership card, a member can either produce their physical card out of their wallet or display their digital card on their smart phone.

#### 8. E-MAIL ACCOUNT ACCESS:

All email accounts were reset so the new Officers could take control of their emails as of **June 7<sup>th</sup>**. This will be the primary means of sending correspondence from State Headquarters to Post and District Officers.

You will receive all General Orders, special notices and any other documentation that you need via email. This will help cut down on postal expenses and speed up the response time for you receiving the information.

- 3. The username is your email address; put that on the first line (see below for your new address).
- 4. Your default password will be **VFW2021!** once you have accessed the mail program you will be asked to change it; it must contain at least one uppercase letter and one number.

#### 11. INCORPORATION:

The attention of the Post Commander is directed to section 708 of the National By-Laws and the Manual of Procedure, which prescribes the procedure for the Incorporation of Units. It shall be the responsibility of the Post

Commander to ensure full compliance with both sections and to ensure that all state requirements for annual filing, fees, etc., are met in a timely manner.

Posts should take the necessary steps to incorporate under the laws of the state in which the Post is located. Financial responsibility laws, as interpreted by the courts, may cause members of unincorporated Posts to be at risk. Incorporating under the provisions of section 708 of the National By-Laws and the Manual of Procedure and the laws of the state will provide protection for Post members. Posts are urged to contact their Department Adjutant to obtain the proper forms for incorporating. The Articles of Incorporation must be reviewed by the Commander-in-Chief prior to forwarding them to the proper state authorities.

#### 12. INSPECTIONS:

Mission Statement: District/Post Inspections are on-site interviews between the Inspector and District/Post leadership where the Inspector acts as an advisor to ensure the District/Post is operating according to the provisions of the VFW Bylaws and that the District/Post operates for the purposes defined in our Congressional Charter. By collecting data, assessing operations, and lending best practices, the Inspector acts as a diligent instructor who imparts knowledge and guidance of District/Post operations. After inspection, the Inspector brings their findings and recommendations to their Leadership's attention in order to create a standard for the District/Post and to ensure a strong foundation for the future.

#### **26.** SCHOLARSHIP ESSAY THEMES:

#### 27. SPECIAL ORDER NO. 9:

In accordance with the provisions of Section 212 of the National Bylaws and upon the recommendation of the Commander, Department of Virginia, while under suspension, due to their failure to establish a meeting quorum or elect the required officers, the charter of Dinwiddie County Post No. 12145, Dinwiddie, Virginia mustered January 31, 2015, is hereby cancelled and the Post declared defunct. Such cancellation includes a revocation of the right to use all trademarks and service marks, including the name, emblems/insignia, seals and logos, of the Veterans of Foreign Wars of the United States.

The Commander, Department of Virginia, will at once recover the charter, rituals, paraphernalia and all monies and other property of the Post in accordance with the provisions of the National Bylaws.

#### 28. VVF POST HOME IMPROVEMENT AND ASSITANCE GRANT:

The Virginia Veterans Foundation, the official foundation of the Virginia VFW, has opened the window to apply for a grant to perform improvements on your Post home. The grant, funded by Powerhouse Gaming, will provide

ten (10) grants worth up to \$1,000 for the 2021-2022 year. The requirements and application are in the attachments. While the project can be completed anytime between July 1, 2021 and June 30, 2022, the application is due no later than November 30, 2021. Entries can be mailed, faxed, or emailed to State Headquarters.

#### 29. VVF COMMUNITY SERVICE GRANT:

The Virginia Veterans Foundation, the official foundation of the Virginia VFW, has opened the window to apply for a grant to perform community service. The grant, funded by Powerhouse Gaming, will provide twelve (12) grants worth up to \$250 for the 2021-2022 year. Should any money remain after the twelve (12) grants are paid out, those not selected in the first round of grants will be considered a second time. The requirements and application are in the attachments. While the project can be completed anytime between July 1, 2021 and June 30, 2022, the application is due no later than November 30, 2021. Posts **AND** Auxiliaries can apply for this grant, but only one grant will be given to an individual Post or their Auxiliary, regardless of who applies. Entries can be mailed, faxed, or emailed to State Headquarters.

#### **30. VIETNAM WAR COMMEMORATION:**

The National Convention adopted a change to the Ritual adding National Vietnam Veterans Memorial Day (March 29) to the list of commemorative dates. This change was submitted by the Department of Virginia.

I have a supply of Vietnam Veteran commemorative lapel pins on hand. Posts wishing to obtain no more than ten may contact me at the email address on my signature block below. Since my last report, I have distributed nine of them (six in person and three others resulting from mail requests received).

This month's Vietnam War Medal of Honor recipient – Wesley L. Fox - was born in Herndon, Virginia and, following the start of the Korean War, enlisted in the United States Marine Corps. During that conflict he was wounded and awarded the Purple Heart and Bronze Star Medal with Combat "V". By May 1966, then a First Sergeant, he was directly commissioned as a 2<sup>nd</sup> Lt while stationed in Europe. Returning Stateside, he became a platoon commander at Camp Pendleton and then, in November 1968, was assigned to 1/9 Marines as "A" Company Commander in Vietnam. The action for which he earned the Medal of Honor occurred on February 22, 1969. The citation accompanying his Medal of Honor reads as follows:

For conspicuous gallantry and intrepidity at the risk of his life above and beyond the call of duty while serving as commanding officer of Company A, in action against the enemy in the northern A Shau Valley. Capt. (then 1st Lt.) Fox's company came under intense fire from a large well concealed enemy force. Capt. Fox maneuvered to a position from which he could assess the situation and confer with his platoon leaders. As they departed to execute the plan he had devised, the enemy attacked and Capt. Fox was wounded along with all of the other members of the command group, except the executive officer. Capt. Fox continued to direct the activity of his company. Advancing through heavy enemy fire, he personally neutralized 1 enemy position and calmly ordered an assault against the hostile emplacements. He then moved through the hazardous area coordinating aircraft support with the activities of his men. When his executive officer was mortally wounded, Capt. Fox reorganized the company and directed the fire of his men as they hurled grenades against the enemy and drove the hostile forces into retreat. Wounded again in the final assault, Capt. Fox refused medical attention, established a defensive posture, and supervised the preparation of casualties for medical evacuation. His indomitable courage, inspiring initiative, and unwavering devotion to duty in the face of grave personal danger inspired his Marines to such aggressive action that they overcame all enemy resistance and destroyed a large bunker complex. Capt. Fox's heroic actions reflect great credit upon himself and the Marine Corps, and uphold the highest traditions of the U.S. Naval Service.

The Medal was presented to him by President Nixon at a White House ceremony. Fox retired from the Marine Corps in 1993 as a Colonel. Post retirement, he served for eight years as deputy Commandant of Cadets at Virginia

Tech. Colonel Fox passed away at his residence in Blacksburg, Virginia in November 2017 and is interred at Arlington National Cemetery.

## VFW Post Home Improvement and Assistance Grant

The purpose of the VFW Post Home Improvement bs Assistance Grant is to assist VFW Posts in Virginia who need assistance with funding projects to improve, expand, or repair their Post home as well as assisting those Posts in financial need. There will be ten (10) grants worth up to \$1,000 each for the 2021-2022 year. All requirements must be met or the Post will be required to return the grant, in part or in whole, depending on the circumstances.

The requirements of the grant are as follows:

- 1) If funding a project, it must be initiated and completed in the period of July 1<sup>st</sup>, 2021 through June 30<sup>th</sup>, 2022. Post must submit a thorough justification for the grant.
- 2) If asking for emergency assistance, the Post must explain the reason for the emergency and provide a plan for how the Post will raise money in the future and prepare for future problems.
- 3) The VFW Post in question must have a current non-profit status on file with the Internal Revenue Service (IRS) and must provide the IRS paperwork proving this.
- 4) The Post must be in good standing with the VFW National and Department Headquarters.
- 5) If funding a project, the Post must own or lease the Post and must provide a copy of the documents showing either ownership or a current lease. For Posts who lease the property, there must be at least 2 years remaining on the lease to receive a grant.
- 6) The Post must not allow smoking in their Post building but may use the grant to repair damage after voting to ban smoking. A ban on smoking is defined as no smoking allowed inside the building of the Post home. It may be allowed outside of the building.
- 7) Receipts for the project or bills covered by the assistance requested must be provided and payment of the grant will not occur until this is done with all payments coming after project completion or for bills already paid.
- 8) Should the project costs or assistance requested total less than \$1,000 once complete, the balance of the grant will not be paid. Additional projects may not be added to an approved grant. Alterations to an approved grant require approval by the Virginia Veterans Foundation before the grant can be claimed.
- 9) The VFW Post receiving the grant must agree to allow the VFW Department of Virginia and Virginia Veterans Foundation the opportunity to promote the funded project on social media, in official communications, and in other forms of marketing.
- 10) The grant will only cover materials and the Post is responsible for providing labor. This can be done through paying for labor or by doing the work themselves.
- 11) All decisions on grants are final and will be made by the Board of Directors for the Virginia Veterans Foundation.
- 12) Funding from this grant program may be combined with other grants but the total of the funding received cannot exceed actual costs and the amount received from this grant may be reduced accordingly.

## VFW Community Service Grant

The purpose of the VFW Community Service Grant is to assist VFW Posts and Auxiliaries in Virginia who need assistance with funding community service projects. There will be of twelve (12) grants worth up to \$250 each for the 2021-2022 year. All requirements must be met, or the grant must be returned, in part or in whole, depending on the circumstances.

The requirements of the grant are as follows:

- 1) The project must be initiated and completed in the period of July 1<sup>st</sup>, 2021 through June 30<sup>th</sup>, 2022.
- 2) The VFW Post or Auxiliary in question must have a current non-profit status on file with the Internal Revenue Service (IRS) and the Post must provide the IRS paperwork proving this.
- 3) The Post or Auxiliary must be in good standing with the VFW National Headquarters and the Department of Virginia.

- 7) Should the project costs total less than \$250 once completed, the balance of the grant will not be paid. Additional projects may not be added to an approved grant. Alterations to an approved grant require approval by the Virginia Veterans Foundation before the grant can be claimed.
- 8) The VFW Post or Auxiliary receiving the grant must agree to allow the VFW Department of Virginia and Virginia Veterans Foundation the opportunity to promote the project on social media, in official communications, and in other forms of marketing.
- 9) The grant will only cover materials and the Post is responsible for providing labor. This can be done through paying for labor or by doing the work themselves.
- 10) All decisions on grants are final and will be made by the Board of Directors for the Virginia Veterans Foundation.
- 11) Funding from this grant program may be combined with other grants but the total of the funding received cannot exceed actual costs and the amount received from this grant may be reduced accordingly.



Comrades my name is Mark Maggio and I am running for State Surgeon. I moved from New York to Virginia in 2003. I have served in a variety of positions since living in Virgina and most recently served as the State Chief of Staff for Commander Eric Mallete. In my positions with the Posts, Districts and State, I have accumulated experience in the business of the VFW and feel that I am ready to serve my fellow comrades as a state officer and eventually State Commander. My goals are to continue the work that has been done by the state over the years growing the membership and reaching out to new members, and continuing to make the VFW a strong voice for veterans.

I enlisted in the Army November of 1982 and went to Basic Training at Fort McClellan, Alabama. I served as a Smoke Generator Operator until receiving my commission from Hofstra University in May 1986 as a Chemical Officer. I served as a platoon leader and executive officer of the 363<sup>rd</sup> Chemical Company and was transferred to the 318<sup>th</sup> Movement Control Agency just prior to deploying to Saudi Arabia for Desert Shield and Storm. During Operation Desert Storm I served as Freight Movements Officer from October 1990 till July of 1991. I returned home and went on to the Transportation Officer Advanced Course then went on to serve as a Company Commander of the 623<sup>rd</sup> Transportation Company. I then served in various staff assignment in the 354<sup>th</sup> and 436<sup>th</sup> Transportation Battalions. I later served with the 1179<sup>th</sup> Transportation Brigade and the Surface Deployment and Distribution Command where I served tours in both Afghanistan and Iraq. In Iraq I was awarded the Bronze Star Medal for establishing a redeployment system that streamlined the process of units moving in and out of theater while minizing the disruption of the change over operations and combat operations.

While serving in Post 4639 I served as Jr and Sr Vice Commander becoming Commander in 2010. I was an All State Commander in my first year. In 2018 I was elected District 3 Commander and was an All American District Commander in my first year and a All State District Commander in my second. In 2018 11 of the 15 posts in the district made All State and 7 made All American. I was asked by Commander Mallete to be his Chief of Staff and worked in that position during the 2020-21 term. I am a member of the State Honor Guard and I am currently the Treasurer of the Commanders Club. I am also a member of the Military Order of the Cooties, where I currently serve as the Sky Pilot.

I am currently employed by the United States Army working at Fort Eustis for the Future Concepts Center under the Army Futures Command. I have been a civilian employee of the Department of the Army since 2010. My girlfriend Rosanne is a member of the Auxilliary and her father was a victim of Agent Orange which took his life in 2001. I have lost several comrades who served in Vietnam to Agent Orange and cancer. I have lost comrades to suicide as well. It is the rememberance of those lives that drive me to a voice for veterans whose voice may be lost in the din of competing voices for Government resources and aid. I want to be the voice that breaks through and helps them get the aid that they fought for and sacrificed for. We must always remain vigilant and never assume our work is finished.
